READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS**

Agree for myself and (if applicable) for the member of my family, to the following:

1. **AGREEMENT TO FOLLOW DIRECTIONS.** I agree to observe and obey all posted rules and warning, and further agree to follow any oral instruction or directions given by Langston Motorsports, or the employees, representatives or agents of Langston Motorsports.
2. **ASSUMPTION OF THE RISKS AND RELEASE.** I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Langston Motorsports for injury, loss or damage arising out of my participation in the Langston Motorsports Dual sport Ride.
3. **INDEMNIFICATION.** I agree to indemnify and defend Langston Motorsports against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs
4. **APPLICABLE LAW.** Any legal equitable claim that may arise for participation in the above shall be resolved under California law.
5. **NO DURESS.** I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire.
6. **REPRESENT AND WARRANT** that I have had sufficient experience with motorcycles to understand all the risks involved in motorcycle riding; that I am not relying on any oral or written representations or statements made with respect to the safety of motorcycle riding, other than what is set forth in this Agreement; that I will wear protective riding gear, including a DOT approved helmet, goggles, long sleeve shirt, long pants, boots and gloves, at all times when participating in any riding activity; that I am in good health and have no physical condition that would restrict or prevent me from participation in any riding activity.
7. **ACKNOWLEDGE AND UNDERSTAND** that motorcycle riding is inherently dangerous and can cause serious personal injury, including PERMANENT DISABILITY, PARALYSIS, and DEATH; that motorcycle group riding involves risks, dangers, and hazards in addition to those normally associated with motorcycle riding agree to obey all traffic laws and Langston Motorsports staff instructions.
8. **AGREE TO RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE THE RELEASED PARTIES** from any and all liability, actions, claims, demands, losses, damages, expenses, and causes of action of any and every kind that I or my successors, heirs, next of kin, executors, administrators, assigns, and anyone else acting on my behalf have, may have, or hereafter accrue against the RELEASED PARTIES, arising directly or indirectly out of or relating to my operation or my own vehicle. This WAIVER AND RELEASE shall include, without limitation, any and all liability, actions, claims, demands, losses, damages, expenses, and causes of action for ALL PERSONAL INJURY, DEATH, AND/OR PROPERTY DAMAGE that I or my successors, heirs, next of kin, executors, administrators, assigns, and anyone else acting on my behalf have, may have, or hereafter accrue for the NEGLIGENCE of the RELEASED PARTIES. This release and waiver is specifically intended to include any claim that may accrue in the future, including any claim that may accrue for wrongful DEATH.
9. I have a valid motorcycle operator license that will enable me to legally operate the motorcycle I will be riding. I further agree that I have the proper auto liability insurance to operate a motor vehicle on public streets. I will pay for costs of repairs for any damage I cause as a result of my operation of my own vehicle including but not limited to vehicle accidents and or improper use of the vehicle
